

CAREGIVER'S MEMBER TERMS OF USE

Welcome to our website and for considering becoming a Member of **KEEP SAFE CARE DIRECT** ("**KEEP SAFE CARE DIRECT**", "**KSCD**"). If you continue to browse and use this website, you are agreeing to comply with and be bound by the following membership terms and conditions of use, which together with our privacy policy govern KEEP SAFE CARE CORP's relationship with you in relation to this website. If you do not accept these Terms of Use or you do not meet or comply with their provisions, you may not use the Website.

THESE TERMS AND CONDITIONS MAY BE UPDATED AND REVISED OCCASSIONALLY, SO PLEASE REVIEW THIS INFORMATION PERIODICALLY. Only registered members have access to the Members Only section.

The Site is a conduit designed to connect home Caregivers ("**Caregivers**") with Careseekers or Recipients and their families looking for in-home care services ("**Careseekers**") and health care resources.

KSCD is in the business of empowering both Caregivers and those looking for care with the best tools and services available and provide our visitors and members, be they Caregivers or individuals requesting, seeking or receiving care (collectively, "You" or "Your") with a service designed to facilitate the best matching of home Caregivers with Careseekers and their families looking for home and elder care services. Your use of KSCD's service, software, products and web sites (referred to collectively as the "Services") is subject to these terms and conditions (the "**Caregiver's Member Terms of Use**") and form a binding agreement between you and KSCD.

KSCD may change the terms of this "**Caregiver's Member Terms of Use**" from time to time on a going-forward basis. We will notify you of any such material changes by posting notice of the changes on the Site, and/or, in our sole discretion, by email (for Members only). Any such modifications become effective upon the earlier to occur of (i) Your acknowledgement of such modifications; or (ii) Your continued access to and/or use of the Site or Services after we post notice of such modifications. It is your sole responsibility to check the Site from time to time to view any such changes to the terms in the "**Caregiver's Member Terms of Use.**" If you do not agree to any changes, if and when such changes may be made to the "**Caregiver's Member Terms of Use,**" You must cease access to the Site and use of the Services. You give us permission to email you for the purpose of notification as described above.

1. MEMBER ELIGIBILITY AND ACCOUNTS

A. Eligibility. By using the Site, You represent and warrant that:

- You are at least 18 years old;
- You are and will continue to be a United States citizen and/or a person legally authorized to work in the United States;
- You have the right, authority and capacity to enter into this Agreement;
- You will abide by all the terms and conditions of this Agreement;
- Neither You, nor anyone in your household (A) has been the subject of a complaint, restraining order or any other legal action, arrested for, charged with or convicted of any criminal offense or (B) has been and/or is currently required to register as a sex offender in any jurisdiction or with any governmental entity.

- B. Member Accounts.** A Visitor may browse the Site in accordance with the “**General Terms of Use,**” but will not have access to certain Services without first becoming a Member. In order to use the Services available to a Member, you are required to create an Account with KSCD. When you create an Account, you will need to select a unique user ID and password (collectively “**Account Credentials**”). In creating your account, you certify that all information you provide to us is true, accurate, current and complete, and you agree to maintain and promptly update such information to keep it true, accurate, current and complete. Members registered as Caregivers may not transfer or share Your Account Credentials with any third parties. In any case, you are solely responsible for maintaining the confidentiality of your Account Credentials. You acknowledge and agree that we rely on Account Credentials to know whether users accessing the Site and using our Services are authorized to do so. If someone accesses our Site or Services using your Account Credentials, we will rely on those Account Credentials and will assume that it is really you who is accessing the Site and Services. You are solely responsible for any and all use of your Account Credentials and Account and all activities that occur under or in connection with your Account Credentials or Account. You agree to be responsible for any act or omission of any users that access the Site or Services under your Account Credentials. You agree not to register for more than one Caregiver Account or register for an Account on behalf of any group or entity.
- C. Administrative Members:** Caregivers are NOT allowed to be administrative members for other Caregivers. A Caregiver may assist a Careseeker in managing other Caregivers but only through the Careseeker’s account. Caregivers may use the same email Account Credentials to be an administrator for a Careseeker as a family member.

2. RISK.

Your use of any information or materials on this website is entirely at your own risk, for which KSCD shall not be liable. It shall be your own responsibility to ensure that any products, services or information available through this website meet your specific requirements.

3. MEMBER VERIFICATION.

- A. Member Verification by Members.** You are responsible to make your own decision regarding other Members that you engage through the Site. KSCD does its best to remove individuals who are abusive, have had complaints made against them, or are soliciting members, but we do not guarantee we can identify all members who may be abusing the service.
- B. Background Screens.** KSCD will make a third-party verification service available to Members. Members looking to engage with a Caregiver may use this service to verify information such as, but not limited to, name, address, social security number, references, driving record, and criminal background. Use of a third-party verification service is voluntary but will be strongly encouraged to be conducted. If a Careseeker decides to use or access information provided by a third-party verification service offered through the Site, you do hereby represent, understand and expressly agree that KSCD is a conduit for the third-party verification service and does not have control over or assume any responsibility for the quality, accuracy, or reliability of the information

provided by the third-party verification service. If you use the third party verification service, and such verification is governed by the Fair Credit Reporting Act (the "FCRA"), you represent and warrant that you will comply with the FCRA, which can be found at <http://www.ftc.gov/os/statutes/fcrajump.shtm>. **KSCD expressly disclaims any and all liability that may result from the use of the information provided by the third party verification service. KSCD expressly disclaims, and you expressly release KSCD from, and agree to indemnify KSCD for any and all liability whatsoever for any controversies, claims, suits, injuries and/or damages arising from and/or in any way related to (a) any misstatements and/or misrepresentations made by any Member or (b) THE ACCURACY, TIMELINESS OR COMPLETENESS OF ANY BACKGROUND CHECK provided to you in connection with the site or the services.**

- C. Optional Member Verification by KSCD.** You understand and agree that KSCD has the right, but not the obligation, to independently verify any statement made by any Member on the Site or verify that any Member meets any of the eligibility criteria set forth above. In the event that KSCD chooses to verify the representations and warranties or any information provided by You through Your use of the Site, You hereby authorize KSCD, either directly or through our vendors or service providers, to attempt to verify such information, which verification may include, without limitation, conducting criminal background checks, sex offender registry checks, motor vehicle records checks, identification verifications, credential verification checks, credit checks and/or using available public records. You consent to any collection, use or disclosure in order to accomplish such verification.
- D. KSCD is a Conduit.** The Site is a conduit designed to connect home Caregivers ("Caregivers") with Careseekers or Recipients and their families looking for home care services ("Careseekers"). KSCD does not provide or arrange for home healthcare services other than in the context of allowing the use of its web site to facilitate an agreement between a Caregiver and a person looking to employ an independent Caregiver. KSCD does not participate in the interaction between Caregiver and Careseeker except to process payments on behalf of Caregivers and collect payments from Careseekers who use any of the KSCD Services (defined below). KSCD does not provide any healthcare billing services. Any disputes related to the services received by Careseeker or payment due to Caregiver must be resolved directly between Careseeker and Caregiver. You understand and agree that KSCD has no control over and is not responsible for the acts or omissions of any Members on or off the Site. You also understand and agree that KSCD makes no representation or warranty regarding the quality of any services provided by any Member. **KSCD IS NOT RESPONSIBLE FOR THE ACCURACY OR RELIABILITY OF ANY INFORMATION PROVIDED BY ANY MEMBER ON THE SITE. KSCD MAY HELP, AT ITS OWN DISCRETION, RESOLVE BILLING DISPUTES, AND WILL DO ITS BEST TO ENSURE THAT ONLY THE HIGHEST QUALITY CAREGIVERS ARE USING ITS SERVICE.**
- 4. RESTRICTIVE CONVENANTS. KSCD EXPRESSLY DISCLAIMS, AND YOU EXPRESSLY RELEASE KSCD FROM, ANY AND ALL LIABILITY WHATSOEVER FOR ANY DAMAGES, SUITS, CLAIMS AND/OR CONTROVERSIES THAT HAVE ARISEN OR MAY ARISE FROM AND/OR IN ANY WAY**

RELATE TO ANY ACTS OR OMISSIONS OF MEMBERS ON OR OFF THE SITE, INCLUDING WITHOUT LIMITATION THE PROVISION OF ANY CARE SERVICES BY YOU AS A CAREGIVER.

Your use of this website and any dispute arising out of such use of the website is subject to the laws of the state of Texas.

5. OWNERSHIP.

A. Acknowledgement. You understand and acknowledge that the software, code, proprietary methods and systems used to provide the Site or Services ("**Our Technology**") are: (a) copyrighted by KSCD and/or our licensors under United States and international copyright laws; (b) subject to other intellectual property and proprietary rights and laws; and (c) owned by KSCD or our licensors. Our Technology may not be copied, modified, reproduced, republished, posted, transmitted, sold, offered for sale, or redistributed in any way without our prior written permission and the prior written permission of our applicable licensors. You must abide by all copyright notices, information, or restrictions contained in or attached to any of Our Technology. Nothing in these **Member Terms of Use** grant you any right to receive delivery of a copy of Our Technology or to obtain access to Our Technology except as generally and ordinarily permitted through the Site according to these **Member Terms of Use**. Furthermore, nothing in these **Member Terms of Use** will be deemed to grant, by implication, estoppels or otherwise, a license to Our Technology. You are entirely responsible for each individual item of Content that you post, email or otherwise make available on the Site or the Services. You grant us a non-exclusive, royalty-free, fully paid, fully sublicensable, worldwide license, under any and all of your copyright and other intellectual property rights related to that Content. - Is discriminatory, unlawful, tortuous, obscene, fraudulent, defamatory, harmful, threatening, pornographic, indecent, vulgar, harassing, discourteous, hateful, abusive or racially, ethnically, religiously, sexually or otherwise offensive, as determined by us in our sole discretion;
- Discloses or provides information protected under any law, agreement or fiduciary relationship, including but not limited to proprietary or confidential information of others;
- Misrepresents your identity in any way;
- Contains any viruses, Trojan horses, worms, time bombs, cancelbots, or other disabling devices or other harmful component intended to damage, detrimentally interfere with, surreptitiously intercept or expropriate any system, data or personal information;
- Contains any advertising or solicitation for anything other than home care services offer through the Site;
- Advocates or encourages any illegal activity; or
- Has the potential to create liability for us or cause us to violate the requirements of or to lose the services, in whole or in part, of our Internet service providers or other suppliers.

Though we strive to enforce these rules with all of our Members, and our other customers, you may be exposed through the Site or Services to content that violates our policies or is otherwise offensive. You access the Site and Services at Your own risk. We may, but are not obligated to, delete Accounts and/or remove Content from the Site if we determine or suspect that those Accounts or Content violate the terms of these **Caregiver's Member Terms of Use** or the applicable agreement with the offending Member(s). We take no responsibility for your exposure to content on the Site or through the Services whether it violates our content policies or not.

- C. General Rules of User Conduct.** It is our goal to make access to our Site and Services a pleasant, good and valuable experience for Visitors and all of our Members. Correspondence between Members is for the sole purpose of connecting Careseekers, Caregivers and other Members for purposes relating to a Careseeker's in home care. If you receive the personal information of any other Member through the use of the Services, You may use the information solely as necessary to conduct a transaction through the Site and Services. You may not use another Member's personal information for any other purpose. You agree not to, and represent and warrant that you will not reproduce, duplicate, copy, sell, resell or exploit any portion of the Site or Services, use of the Site or Services or access to the Site or Services for any purposes other than for which the Site or Services are being provided to you, or do any of the following:
- D. Rules of Conduct.** You agree not to:

- Recruit, solicit or contact any Member for employment or contracting for a business not affiliated with KSCD;
- Contact other Members for any purpose other than as set forth in these **Caregiver Terms of Use**;
- Harass, intimidate or otherwise engage in illegal or offensive behavior with respect to any other Member;
- Conduct or promote any illegal activities while using the Site or Services;
- Upload, distribute or print anything that may be harmful to minors;
- Attempt to reverse engineer or jeopardize the correct functioning of the Site, or otherwise attempt to derive the source code of the software (including the tools, methods, processes, and infrastructure) that enables or underlies the Site;
- Attempt to gain access to secured portions of the Site or Services to which you do not possess access rights;
- Upload or transmit any form of virus, worm, Trojan horse, or other malicious code;
- Use the Site or Services to generate unsolicited email advertisements or spam; allow, enable, or otherwise support the transmission of mass unsolicited, commercial advertising or solicitations via e-mail (spam);
- Use the Site or Services to stalk, harass or harm another individual;
- Use any high volume automatic, electronic or manual process to access, search or harvest information from the Site or Services (including without limitation robots, spiders or scripts);

- Impersonate any person or entity, or otherwise misrepresent Your affiliation with a person or entity; or
- Mirror or frame the Site or any Content, place pop-up windows over its pages, or otherwise affect the display of its pages.

6. PAYMENTS.

The Site and basic Services of KSCD, including access to the basic KSCD information network and KSCD forums, are free for Members. Other Exclusive services, including training information, shift scheduling, time management, invoicing and payment processing services, and some KSCD generated content (collectively, “**Exclusive Services**”) are included to Members who have completed their profiles and are “active” members. By using our **Exclusive Services**, Caregiver agrees to a fee charged by KSCD then in effect unless specifically notified otherwise. KSCD reserves the right, at any time, to modify its fees and/or billing methods. In exchange for the

Exclusive Services, Caregiver authorizes KSCD to deduct the then-current fee from all payments processed by KSCD or a third-party service provider on Caregiver's behalf. When Caregiver uses our **Exclusive Services**, then:

- A. Each Sunday, a time sheet of work hours is created for each Careseeker to whom a Caregiver provided care during the previous week;
- B. A work hour approval notice is then emailed directly to the Careseeker and/or the person who is designated to pay on behalf of the Careseeker, and is made available to the applicable Careseeker through the Site;
- C. The Careseeker reviews the work hours and, if approved, then the Careseeker will initiate payment;
- D. If there are errors on the timesheet (work hours), the Careseeker will contact the Caregiver(s) to request appropriate changes;
- E. If the Careseeker approves the work hours, the Careseeker is billed via debit card, and an ACH payment is sent to the Caregiver(s);
- F. If a Caregiver has not submitted their work hours by Sunday at 11:59:59PM then the timesheet becomes overdue, and is placed in Unresolved Work Hours;
- G. If the Careseeker has not approved the work hours by Tuesday 11:59:59 PM of the Careseeker's time zone of the same week, then the work hours are put into a unresolved status;
- H. If there are insufficient funds in the Careseeker's credit card and there is not an alternative method of payment, both the Caregiver and Careseeker will be notified by email. Since the Caregiver is an employee of the Careseeker, it is the obligation of the Caregiver to collect payment as KSCD is only acting as a payment agent for the Careseeker;
- I. If funds are collected and there is no dispute on the calculated amount; Funds debited for payment to the Caregiver will be directly deposited into Caregiver's bank account within 2 days of initiating an ACH payment according to the banking details provided by Caregiver.
 - Each Caregiver must accurately enter or verify his/her time worked into the KSCD time sheet on line and submit it for payment by 11:59:59 PM Sunday. Failure to do so will delay payments for any time worked.
 - KSCD may in the future offer a geo-location check-in smart phone service to Caregivers to verify arrival and departure times from the Careseeker's location. Until then it is the responsibility of the Caregiver to verify the times worked.
 - Any time sheet that is **under dispute** and not resolved by 11:59:59 PM Tuesday the week of submission, will not be paid that week, and will roll over to the week the time sheet hours are resolved.
 - Caregiver is solely responsible for the accuracy of his or her bank details, including Caregiver's bank account number, bank routing number or debit card number. KSCD offers account verification through a micro-deposit confirmation. KSCD expressly

disclaims all liability related to errors in fund deposits due to inaccurate or incomplete bank details submitted by Caregiver.

You expressly authorize KSCD's service provider, Dwolla, Inc. to originate credit transfers to your financial institution account. KSCD expressly disclaims any and all liability for any claims or damages related to KSCD's use of third party payment processing services, including without limitation any damage that may result should any such information be released to any third parties.

7. EXCLUSIVE USE OF PAY SYSTEM.

All payments relating to services provided by a Caregiver to a Careseeker must be made through the payment channels provided or specified by KSCD. No Careseeker may make any payments directly to a Caregiver through any other payment channels. **Any action that encourages or solicits complete or partial payment outside of the KSCD system is a violation of this Agreement.** Should a Careseeker be found in violation of this section of the **Caregiver's Member Terms of Use**, they will owe KSCD fees equal to the greater of a) \$2,500; or b) the yearly membership fees had the payments been processed through the KSCD system plus 10%. You shall immediately notify KSCD if another Member requests that payment be made directly or through any channels other than those provided or specified by KSCD. Acceptance of payments outside the approved KSCD channels or without the approval of KSCD may result in the permanent removal of both the Caregiver and the Careseeker, and each party may not be allowed to use the system again without paying a \$250 reinstatement fee. This paragraph is also applicable to a Careseeker who finds a Caregiver using the KSCD site and decides to pay the Caregiver directly circumventing the Keepsafecaredirect.com system to hire or pay them. In this case, KSCD reserves the right to access a \$2,500 finder's fee to the Careseeker's account and both parties will be removed from the KSCD site.

8. TEXT MESSAGES.

KSCD may send Members text messages (SMS) in connection with the Services or otherwise. Receipt of the text messages from KSCD is voluntary. By providing your phone number, you give KSCD express permission to send SMS text messages to your cellular phone and/or mobile device. Additionally, you do hereby represent, understand and expressly agree that KSCD does not have control over or assume any responsibility for the quality, accuracy, or reliability of this Service. Carrier charges may apply for receiving SMS text messages. You are solely responsible for any costs you incur when receiving SMS text messages from KSCD.

9. KSCD DIRECT MESSAGING/FORUMS/SERVICES.

KSCD Members may use KSCD Direct Messaging designed to facilitate communication between Careseeker or Recipients and their families with Caregivers and other Members that the Careseeker or Recipient wishes to share information with, such as their healthcare service providers. The KSCD Direct Messaging Service posts messages to a Member's account as well as sends an email to Member's designated email account and any persons associated with Careseeker, also known as a Care Circle, email account.

The KSCD Forums includes discussion forums, document sharing, posting announcements, scheduling events and related services.

10. PROFESSIONAL ADVICE.

All information, materials, content and/or advice on the Site or provided through the Services is for informational purposes only and is not intended to replace or substitute for any professional, financial, medical, legal or other advice. KSCD expressly disclaims, and you expressly release KSCD from, any and all liability concerning any treatment, action by, or effect on any person following the information offered or provided within or through the Site. You should consult with an appropriately trained specialist for all concerns that require professional, legal, or medical advice.

KSCD does provide experienced Registered Nurses to offer resource information to help a Careseeker and their family; obtain or connect with professionals in their local healthcare community.

11. PROMOTIONAL OFFERS.

We may run promotional offers from time to time on the Site. The terms of any such promotion will be posted on the Site. Unless otherwise indicated, we may establish and modify, in our sole discretion, the terms of such offer and end such offer at any time.

12. MODIFICATIONS TO THE SITE OR SERVICES.

- A. Modifications or Discontinuation.** We reserve the right to modify or discontinue the Site or Services with or without notice to you. We will not be liable to you or any third party should we exercise our right to modify or discontinue the Site and/or Services. If you object to any such changes, your sole recourse will be to cease access to the Site or Services.
